The **Dignity for All Students Act** focuses on helping everyone be safe in and out of school.

#### **Dignity Act**

The Dignity Act states that NO student shall be subjected to harassment or discrimination by employees or students on school property or at a school function based on their actual or perceived (supposed) race, color, weight, national origin, ethnic group, religion, religious practice, disability, sexual orientation, gender, or sex. It is nice to be important...

### it is more important to be nice.

Bullying, discrimination and, harassment are very serious words and situations involving these behaviors will be taken and handled seriously, even if it happens on the Internet or through text messages.

Telling jokes can be fun, but when it hurts someone physically or emotionally, it is not. This is never acceptable at Mount Sinai High School.

Most of the time people are apprehensive to tell that something bad is happening to them or others. **Telling is not tattling.** Telling is trying to get someone **out of** trouble. Tattling is trying to get someone **into** trouble. There is a difference!

If you have a problem, you should tell someone. Your parents, bus drivers, teachers, counselors, the nurse, the Assistant Principal, and Principal are all here to help. A **complaint** form can be found on the high school's website or in hard copy format in the main office. A. **Student Rights** - The District is committed to safeguarding the rights given to all students under state and federal law. In addition, to promote a safe, healthy, orderly and civil school environment, all District students have the right to:

- Take part in all District activities on an equal basis regardless of race, color, creed, national origin, religion, gender or sexual orientation or disability.
- Present their version of the relevant events to school personnel authorized to impose a disciplinary penalty in connection with the imposition of the penalty.
- Access school rules and, when necessary, receive an explanation of those rules from school personnel.

B. **Student Responsibilities** - All students have the responsibility to:

- Contribute to maintaining a safe and orderly school environment that is conducive to learning and to show respect to other persons and property.
- Be familiar with and abide by all District policies, rules and regulations dealing with student conduct.
- Attend school every day, unless they are legally excused, and be in class, on time and prepared to learn.
- Work to the best of their ability in all academic and extracurricular pursuits and strive toward their highest level of achievement possible.
- React to direction given by teachers, administrators and other school personnel in a respectful, positive manner.
- Work to develop mechanisms to control their anger.
- Ask questions when they do not understand.
- Seek help in solving problems that might lead to discipline.
- Dress appropriately for school and school functions.
- Accept responsibility for their actions.
- Conduct themselves as representatives of the District when participating in or attending school-sponsored extracurricular events and to hold themselves to the highest standards of conduct, demeanor and sportsmanship.

Note: Students should consider school their place of business and conduct themselves accordingly.

## Prohibited Student Conduct

Discipline is most effective when it deals directly with the problem at the time and place it occurs, and in a way that is viewed as fair and impartial by the student. Before seeking outside assistance, teachers will first use all their resources to create a change in behavior in the classroom. When the teacher has made every effort to bring about positive behavioral change, and has been unsuccessful, the student will be referred to building administration. At that point, administration will decide what further action will be taken in accordance with the Code of Conduct found in the Parent / Student Handbook and on the District's website.
